Dear Parents:

Thank you for your inquiry into New Horizons Youth Ministries! Our ministry supports two separate therapeutic long-term boarding schools and three therapeutic summer programs.

New Horizons Academy and our international office are located in Marion, Indiana. Escuela Caribe is located in Jarabacoa, Dominican Republic. Missanabie Woods Academy, our summer camp, is located in Missanabie, Ontario, Canada. While each of our schools and the camp has their own unique therapeutic emphasis, all share commonalities: (a) Christian child care philosophy and practices, (b) compassion for youth in need, and most importantly, (c) a ministry for Jesus Christ.


Enclosed are some materials that are, for the most part, self-explanatory. Read them carefully to become acquainted with New Horizons Youth Ministries.

A normal enrollment sequence would be:

1. Submission of the completed Parent Application/Social History Form and the Child's Problem Checklist. These forms should be completed by the mother, whenever possible.
2. Submission of a professional evaluation completed within the last two years, with the student's latest DSM (Diagnostic and Statistical Manual of Mental Disorders) classification.
3. Submission of all psychological testing on the child. We prefer the Millon Adolescent Clinical Inventory (MACI); however, if you have had other testing done, have it sent and we will let you know if it is not sufficient.
4. If you are applying for a grant, submission of your most recent 1040.
5. Once all the information is received, the Enrollment Committee will make an informal decision within 5-7 days. This notification is usually made by phone followed by a formal letter of acceptance, which will be mailed to you.
6. Additional information and enrollment forms will be provided upon acceptance of your child into one of the New Horizons supported schools or summer camps.
7. Acceptance of enrollment is secured upon receipt of completed authorization forms and signed School Financial Enrollment Agreement. It is our policy to run a credit check on those applying for admission to New Horizons Youth Ministries.

## **New Horizons: A Brief History**

New Horizons Youth Ministries was founded in 1971 as a response to the sudden, rapid deterioration in the lifestyle of our nation's youth. Although much was being done for the actual delinquent, there were virtually no other Christian therapeutic schools available to the thousands of parents anguishing over their underachieving teenagers who were lacking academic motivation, making poor peer choices, and generally not fulfilling parental expectations.

Our first school, Escuela Caribe (also known as Caribe Vista School), began by taking these high-potential students off to a mission field, away from negative influences, to do service projects for the poor. Intense academics, augmented by counseling and group work, usually results in the students having a new love for their family and a positive determination to have God's will in their life. A campus of thirty acres is situated in the mountains near Jarabacoa in the Dominican Republic, West Indies.

Through the vision and generosity of Hugh and Nancy MacLellan, our Missanabie Woods (Survival) Academy was started in the unspoiled beauty of Northern Ontario in 1976. Here at our 460-acre setting on Dog Lake, we have developed a substantial campus for this multi-faceted summer school, which accommodates approximately 45 teenagers and 35 staff members. Most students attend only one summer.

On December 9, 1982, the Roosevelt Elementary School, located three miles southeast of Marion, Indiana, was purchased from the Marion Community Schools to be used as a headquarters facility and a boarding school. The facility was understandably named New Horizons Academy. Amid much debris and confusion, school started here in the fall of 1983. Since then a number of attractive residential homes have been added on the campus, which now consists of eight buildings on 120 acres.

Students normally return into society or home from the Marion campus. A number of students attend either Indiana Wesleyan University or Taylor University in their transition from New Horizons Academy.

## List of Expectations

*Parents may rightfully expect and New Horizons Ministries can generally guarantee the following for each student:*

1. No student will be dismissed for any reason other than pathological. The school will never give up on a student due to problems.
2. All our academies are accredited. Because of our structure, most students will achieve a higher level of academic success than they are currently achieving.
3. Intensive, professionally directed counseling on personal and family problems will be administered throughout the period of residence.
4. Religious instruction and value differentiation sessions will be held on a daily basis, together with weekly church services, youth group, and chapel.
5. Every student will receive regular work assignments in their house and on campus.
6. Every student will receive regular exercise and recreation at least three days per week.
7. The student will not use drugs except as prescribed by a physician for a specific illness. All drug usage will be reported to parent(s).
8. The student will be deterred from any intimate sexual experience.
9. The student will be prohibited from smoking and from the use of alcoholic beverages throughout their enrollment.
10. The student's authority problem will be addressed. "...A child who gets his own way brings shame to his mother."

11. Parents will receive periodic academic and behavioral reports on the progress of their child.
12. Private and group counseling will be available to assist parents in the training of their children. This will help parents understand their child's most important needs and improve their opportunity for success upon returning home.
13. For fifth level students, there will be a behavioral change and an outward compliance to authority for at least three months prior to the student's return.

**Please note:** It is impossible to determine whether or not this compliance will transfer entirely to the home.

14. Most fifth level students can succeed in a normal home, boarding school, or college setting.

In summation, the student leaving with a "recommendation" will not return home perfect or without difficulties. However, their problems should be more manageable for parents who have availed themselves of our assistance in understanding and dealing with their teenager.

## Enrollment Cost Information

Since its beginning, New Horizons Youth Ministries (NHYM) has attracted the interest of many thoughtful and unselfish people. Without their prayers and gifts, the services of this Christian agency would not be available. Several years ago, the Board of Directors made a decision to apply gifts received by NHYM toward keeping the cost of monthly tuition at a minimal rate, thus helping families who experience financial difficulty in providing this type of training for their teenagers.

- The present cost for Escuela Caribe (CVS) and New Horizons Academy (NHA) is a monthly fee that is determined on a sliding-scale basis. This fee ranges from \$2,950 - \$6,200, depending upon what income-based grants are awarded.
- Grants are awarded on a sliding scale, based on the Adjusted Gross Income listed on the IRS Form 1040 that claims the child. Please include a copy of your most recent 1040 with your parent application if interested in financial assistance. You will be notified of the grant amount for which you qualify, or you can call the accounting department at 800-333-4009, ext. 108.
- If you are eligible for any third-party payment, this information must be with your initial application.
- To further qualify for a New Horizons grant, the required tuition payment must be made on or before the 15<sup>th</sup> of each month.
- In almost all cases, the IRS considers costs for child training as a medically deductible expense. If you wish to deduct this expense, you must obtain a statement from your family doctor or other qualified persons, recommending your child attend a therapeutic school like New Horizons Youth Ministries. They must also state that such care is necessary for the social well being and emotional health of your child.

*New Horizons Youth Ministries admits students of any race, color, nationality, or ethnic origin.*

## Insurance Information

*Following is some information that you might find helpful in pursuing insurance coverage for your child enrolled in New Horizons Youth Ministries*

We provide therapeutic Christian education.

Students normally attend group counseling sessions two to three times a week, and individual counseling on a weekly basis and on an as-needed basis. Hours of counseling are documented and may be sent for reimbursement from your insurance company.

We have licensed professionals on staff. Our licensed Clinical Social Workers and our licensed Marriage and Family Therapists supervise all of our counseling sessions.

For our year-round, residential schools we work closely with our contractual Psychiatrist who monitors and prescribes all psychotropic medication for our students. *We must, by law, follow their professional decisions.* This service is not available for our summer only placements.

- Remedial reading or language training for a child with dyslexia or other disability (Revenue Ruling 69-607, C.B. 1969-2,40)
- Special instruction or training-such as lip reading, sign language, speech instruction, braille (Section 213-1/3/Internal Revenue Code 1954)

## **IT IS IMPORTANT TO DOCUMENT ALL YOUR MEDICAL EXPENSES BY:**

- Keeping careful records of all expenses with receipts, date of expense, etc., for at least 5 years, for possible auditing purposes.
- Obtaining certification from your doctor that the expense has been made for one or more of the following: diagnosis, cure, alleviation, prevention, treatment, or dysfunction for your child's mental or physical condition.

## **Educational Profile**

### **Description of Educational Programs**

The schools of New Horizons Youth Ministries (NHYM) are designed for strong, Christian parent(s) who have emotionally troubled, underachieving teenagers. NHYM offers academic credits through New Horizons Academy in Marion, Indiana, and Escuela Caribe in the Dominican Republic.

New Horizons' educational philosophy is summarized by the phrase "therapeutic Christian education." Because students' emotional, behavioral, and relational problems are great hindrances to their school performance, the total programs at NHYM help to provide the underachieving teenager with the structure, caring relationships, and crucial success experiences needed for success in the school setting. ### **Mission Statement**

Each respective education department provides a nurturing environment to train struggling adolescents through a quality educational experience that is challenging and encourages the application of biblical principles that shape their spiritual, mental and emotional character.

### **Accreditation**

New Horizons Academy (NHA) and Escuela Caribe (CVS-Caribe Vista School) provide a quality academic program that is both individually structured and therapeutically integrated to generate positive learning experiences that instill in each student a new hope and confidence in his/her ability to succeed academically, socially, and relationally. ## School Data/Calendar

Our fully staffed residential program maintains almost a one-to-one staff to student ratio. The educational component of our schools consistently maintains a 1-to-6-staff/student ratio.

New Horizons' schools offer a comprehensive, college-oriented and standard high school curriculum. The school calendar is 225 days of instruction and is made up of two, 18-week semesters with 10-week summer sessions in Marion, IN; Jarabacoa, Dominican Republic; and Missanabie, Ontario.

## Curriculum

The school uses a mixture of methods and curricula. Some classes meet a few times a week as a group, while other subjects are worked on independently. We use a combination of Christian publishers and secular textbooks in our effort to integrate and apply the truths of the Bible into the students' lives.

Most students who come to us are in need of the core curricula, though some are able to take advantage of our electives like Spanish, Keyboarding, Microsoft Office 2000, and Fine Arts. The school also measures students' abilities with a variety of tests and is able to help students if they are significantly weak in specific areas.

## Graduation Requirements

In order to graduate from NHYM, a student must earn a minimum of 40 credits and be in residence a minimum of nine months. Our educational standards meet the same requirements as the public schools in Indiana. The Indiana Statewide Testing for Educational Progress (ISTEP) is given yearly to evaluate students' educational progress. In addition, juniors and seniors are required to take the SAT or ACT exams.

# NHYM CURRICULUM OFFERINGS

## **Switched-On Schoolhouse (SOS)**

“Switched-On Schoolhouse 2.0 R2 is a biblically-based curriculum that offers computer-based learning for grades 3-12. SOS provides an interactive learning environment with 3-D animation, video clips, and other fascinating multimedia.” (From SOS material) NHYM uses this curriculum sparingly and only in situations where we do not have a course that matches the students’ needs or the interactive computer work would benefit the student more than our traditional classroom setting. Many of our students who use SOS find it to be very beneficial and are encouraged by their newfound success.

## **Language Arts**

### **Language Arts I - 2 credits**

Through the integrated study of language, writing, literature, and oral communication, this course further develops the students’ use of language as a tool for learning and thinking. Formal study of grammar, usage, and language mechanics is integrated to improve the student’s writing skills to communicate effectively through written and oral communication. Students receive instruction and practice in the writing process including prewriting, drafting, revising, editing and publishing including a 3-5 page research paper using the MLA Handbook for standard research form and style. Composition also provides opportunities in writing literary analysis and a personal narrative. Literature includes the study of a variety of genres and requires students to develop strategies for making critical evaluations of literature, such as identifying literary conventions and determining the authors’ purposes while strengthening skills in paragraph and multi-paragraph writing. Along with reading essays, short stories, drama and poetry, the student will also read two classical novels such as: **Around the World in Eighty Days, To Kill a Mockingbird, Red Badge of Courage, The Giver or Call of the Wild.**

Language Arts Text: **Elements of Writing, 3<sup>rd</sup> Course** (Holt, Rinehart, and Winston) or **House of Language** by Textword

Literature Text: **Implications of Literature** (Textword Press) or **Literature Platinum** (Prentice Hall)

### **Language Arts II - 2 credits**

Through the integrated study of language, writing, literature, and oral communication, this course continues to develop all skills as outlined in Language Arts I. Composition also provides opportunities in creating expository essays of persuasion and literary analysis. The 5-7 page paper incorporates the development of research and library media skills. Studies in literature represent different genres, cultures, times, authors, themes, and forms, requiring the student to engage in reading, thinking critically and responding in writing. Included in the second semester a thematic theme may be emphasized such as drama, a comparative autobiography Holocaust study, a Shakespeare Unit or other appropriate classical novels.

Language Arts Text: **Elements of Writing, 4<sup>th</sup> Course** (Holt, Rinehart, and Winston) or **House of Language** (Textword Press)

Literature text: **Implications of Literature** (Textword Press) **Literature Platinum** (Prentice Hall)

### **Creative Writing - 1 credit**

This course will encourage the student to see the value of what written language can do for him or her. The course will focus on the major aims of writing: self-expression (writer), persuasion (reader), and exposition (subject matter). The four modes of writing, narration, evaluation, classification and description, will continuously be related to the aims of writing. Pre-writing, writing the first draft, and using the guidelines for evaluating and revising will be the standard by which all papers are written. The student will be encouraged to see the joy of writing by choosing his or her own topics and establishing a collaborative learning effort with his or her peers as an audience.

Text: **Elements of Writing, 5<sup>th</sup> Course** (Holt, Rinehart, and Winston)

## Literature 11 - 1 credit

In this course the student will delve into the lives and hearts of the characters, explore the process and purpose of the story, and introspectively respond to the pertinent issues in society. The students will read at least two literature classics such as: **Macbeth** or **Midsummer Nights Dream**, **Lord of the Flies**, **Wuthering Heights** or **The Scarlet Letter**. The student will analyze the literature and write intuitively while making application from the reading. Critical thinking skills will be strengthened as students compare themes of these books with biblical themes. Oral presentations will emphasize effective listening and speaking techniques. Evaluation will encompass all material covered in a unit – including reading assignments, class discussions, presentation, lectures, films, and writing assignments. The books that are selected will be determined according to the literature the student has already been exposed to and to what is appropriate and challenging.

## Literature 12 - 1 credit

In this course the student will read a Shakespearean play: **Hamlet**, **Macbeth**, **The Tempest**, or **Taming of the Shrew** and another classic, such as **A Tale of Two Cities** or **The Odyssey**. The student will study the contents and interpret, analyze, and apply significant elements of each literary work. In addition, students will explore and study Biblical literature from the Bible as one of the most influential, foundational literary works of Western Culture. The books that are selected will be determined according to the literature the student has already been exposed to, and by what is appropriate and challenging.

## Journalism-1 credit *Prerequisite: Language Arts I and II, or equivalent*

A “hands on” journalism course in which students apply and hone Language Arts knowledge and skills in the production of a school newspaper. During this course, students will interview people, write and edit copy, proofread, develop advertising, plan news coverage and layout, produce and distribute the newspaper, as well as track and promote the circulation of the paper. Students will also be learning how to manage tasks and departments of the newspaper. Also photojournalism will be covered with students learning how to work photo assignments and visualize the way the scene will look as a print. Included in the course is a study of the mass media with special emphasis and concentration on the newspaper and its role in our society.

## Applied Language Arts-1 credit

This course takes a “hands on” approach to teaching and strengthening basic language arts skills through a student’s exploration in a field of their interest. Skills such as researching, conventional grammar mechanics, vocabulary acquisition, reading for content and speed, and writing of various types are acquired and practiced while the student investigates topics of their interest. This course is designed to train students to take more personal responsibility for their own intellectual development and learning skills. An evaluation project, designed to pass knowledge and experience gained through this course on to others is required.

## Independent Study in English –1 credit *Prerequisite: Language Arts I and II, or equivalent*

This is an upper level class for students needing an additional English credit. The student and a qualified English mentor meet regularly while the student begins to take on personal responsibility to establish lifetime reading and learning habits. This independent study can be a novel study or an in-depth study into a particular field of writing. Together the student and mentor design a course that explores the topic and meets Indiana 12<sup>th</sup> grade Language Arts academic guidelines. This is an excellent course for beginning the transition from high school to college or technical learning environments.

## Speech - 1 credit

In this one semester course, the student will be taught the basics of proper breathing, projection, proper resonance, pitch, pronunciation, phrasing, posture, gestures, marking script, self-control, and performance. Students also learn about platform presence, developing courage and self-confidence through preparation, how to make your meaning clear and other relative topics.

Text: **Speech** (School of Tomorrow Accelerated Christian Education, Inc.) and **How to Develop Self-Confidence & Influence People by Public Speaking** by Dale Carnegie.

## Spanish I - 2 credits

In this course, the student will be introduced to the Spanish language for creative communication. The focus of the grammar lessons is to encourage the student to be proficient in speaking, listening reading and writing the Spanish language. Culture is integrated throughout the text from the basic introduction of vocabulary to the photographic contributions of the National Geographic Society.

Text: **Buen Viaje! Level 1** (Glencoe-McGraw Hill)

## **Spanish II - 2 credits**

In this course, the student will build on what was taught in Spanish I. The student will also add to his vocabulary and his understanding of the Spanish culture and grammar. The student is encouraged to use his knowledge of Spanish in all the four areas of proficiency. The ability to communicate is stressed and strengthened

Text: **Buen Viaje! Level II** (Glencoe- McGraw Hill)

## **Spanish III - 2 credits**

In this course, students will learn about the culture of many Spanish speaking cultures. They will read literature from a variety of Spanish authors. They will review grammar concepts within the context of culture and literature. Stress will be placed on communicating in Spanish through speaking, writing and listening.

Text: **Buen Viaje! Level III** (Glencoe- McGraw Hill)

# **MATHEMATICS**

## **Math 76 - 2 credits**

This course presents an integrated approach to learning general mathematical skills. This is accomplished by a systematic presentation of written problems that help insure speed, accuracy and the ability to do mental math. The major concepts covered by this text include the following: decimal numbers and money, fractions, linear measurement, area, perimeter and volume, place value, the number line and negative numbers, average, expanded conversion, probability, angle measure, and rectangular coordinates.

Text: **Math 76** (Saxon Mathematics)

## **Math 87 - 2 credits**

This course presents an integrated approach to learning general mathematical skills. This is accomplished by a systematic presentation of written problems that help insure speed, accuracy and the ability to do mental math. The major concepts covered in this course are: place value, lines and angles, using a ruler, equivalent fractions, polygons, perimeter, exponents, prime numbers, fractions, word problems, metric system, ratio, area of a triangle and polygons, stem and leaf plots, decimals and scientific notation.

Text: **Math 87** (Saxon Mathematics)

## **Pre-Algebra - 2 credits**

In this course, the following concepts will be covered: variables, equations, formulas, positive and negative numbers, decimals and percent, square roots, word problems, factoring, graphing, patterns in addition, subtraction, multiplication and division of rational numbers.

Text: **Pre-Algebra** (Glencoe/McGraw-Hill)

## **Algebra I - 2 credits**

In this course, there will be an introduction to algebra and its basic applications. The course will begin by exploring expressions, equations, functions and rational numbers, and then move on to solving linear equations. After this it will cover proportional reasoning and its uses, and then move back to relations and functions and teach about graphing them. With these graphing skills the student will start analyzing and solving linear equations and inequalities, as well as systems of linear equations and inequalities. Next the student will move into exploring polynomials and using factoring. Finally the course will conclude by exploring quadratic and exponential functions, rational expressions and equations, and radical expressions and equations.

Text: **Algebra 1** (Glencoe/McGraw-Hill)

## **Algebra II - 2 credits**

In this course, the student will review concepts learned in Algebra I and then build upon these concepts to explore other applications of algebra. The course will begin by analyzing equations and inequalities, and then move on to graphing linear relations and functions and solving systems of linear equations and inequalities. Next the student will learn about matrices and their uses. At this point the student will begin exploring polynomials and radical expressions, quadratic functions and inequalities, polynomial functions, rational expressions, and exponential and logarithmic functions, as well as analyzing circles and parabolas.

Text: **Algebra 2** (Glencoe/McGraw-Hill)

## **Geometry - 2 credits**

In this course, the student will be introduced to the basic concepts of geometry, as well as explore the integration of algebra to geometry. The course will begin with the basic geometric concepts of points, lines, planes and angles. Reasoning and proof writing will be introduced. The student will apply these beginning concepts while exploring a number of areas. The student will look at perpendicular and parallel lines, learn to identify and apply congruent triangles, explore quadrilaterals, learn about proportions and similar triangles, integrate right triangles and trigonometry, and finally, analyze circles. The student will integrate these concepts in the exploration of coordinate geometry and loci, as well as area, surface area and volume in polygons.

Text: **Geometry** (Glencoe/McGraw-Hill)

## **Pre-Calculus - 1 credit**

In this course, the student will build upon the concepts learned in Algebra 2. They will investigate sequences and series, and discrete mathematics and probability. Next the student will review circles and parabolas, and learn more about conic sections. Finally they will explore trigonometric functions, and then learn to make trigonometric graphs and identities.

Text: **Algebra 2** (Glencoe/McGraw-Hill) and **Pre-Calculus** (Amsco – Foundations for Advanced Mathematics)

# **SCIENCE**

## **Earth Science - 2 credits**

Earth Science is the study of earth and space. It includes but is not limited to the transfer of energy in the atmosphere; progression of land forms; patterns of change that affect weather; the scale and structure of stars and the interactions that occur among the water, atmosphere and land. This course is divided into four sections: geology, meteorology, astronomy and oceanography.

Text: **Earth Science** (Glencoe/McGraw-Hill)

## **Biology - 2 credits**

In this course the student will study the life around us and gain more appreciation for God's amazing designs. The student will learn about the complexity of life and better understand the "why" and "how" questions about the living world. The student will study the scientific methods of experimentation as they participate in laboratory exercises and writing laboratory reports. He or she will learn about the cell, its function and structure, followed by DNA, genetics and heredity. In the second half of the course, the student will study the diversity of life beginning with the smallest creatures, bacteria and viruses, followed by plants and animals. Finally, the student will look into ecology, the resources on earth and the human influence on earth.

Text: **Biology: God's Living Creation** (A Beka Book Publishing)

## **Chemistry - 2 credits**

This course is a college preparatory science class designed to teach the student about principles associated with chemistry. The student will learn about classification and changes of matter, thermodynamics, bonding, chemical reactions and their yields, measurement, bonding, behaviors of elements, and acid/base reactions. In addition, the class will take an in-depth look at God's creation in all of its beauty and complexity. It is recommended that the student have a full year of Algebra I before taking this class.

Text: **Chemistry** (School of Tomorrow -Accelerated Christian Education, Inc.)

## **Physics - 2 credits**

In this course, the student will be exposed to a clear, conceptual development followed by plenty of practice working with fundamental physical concepts, problem-solving skills, questions and text presentation. The student will learn about motion in one and two dimensions, Newton's laws and forces. He will also look at work, energy, momentum, heat, and the mathematics of thermodynamics. Next, he will look into the physical nature of vibrations, waves, sound and light. Then, the student will get a comprehensive look into electricity and magnetism. By integrating mathematics and concepts, the student will learn analytical thinking and processing skills.

Text: **Holt Physics** (Holt)

## **SOCIAL STUDIES**

### **World History - 2 credits**

This course is an overview of the history of the world, beginning with prehistoric people and progressing through the rise of Imperialism. This course also educates the student in developing map skills, critically thinking and improving their writing skills through six, one-page papers on close-ups of different cultures.

Text: **Human Heritage** (Glencoe/Macmillan/McGraw-Hill)

### **World Geography - 2 credits**

This course looks at the physical and cultural geography of the world. It is designed to increase the student's awareness of the world's people, their history, and the present challenges they face with the environment and different ethnic and social groups. The student will study the physical world by completing the Map and Graph Skills and studying maps for the nine map tests. A number of one-page papers will also be written on different environmental problems nations are currently facing.

Text: **World Geography** (Glencoe/Macmillan/McGraw-Hill)

### **U.S. History - 2 credits**

In this course the student will examine the history of the United States from the 1600's through the 1980's. The student will also do research, giving him or her insight on the responsibilities of a historian.

Text: **United States History for Christian Schools** (Bob Jones University Press, 3rd Edition)

### **U.S. Government - 1 credit**

This course begins by looking at Biblical, Greek, and Roman examples of government. Students will study various church governments as well as the four main types of political government and draw comparisons. They will understand the origins, functions, structures, and limitations of American state and federal government, as well as the functions and structures of the different branches that make up the government. Students will study the Constitution and its amendments and learn how political parties are run and organized. They will study the purpose and organization of the United Nations and understand the U.S. foreign policy. Finally, students will learn the importance of their own contribution to the political process.

Text: **U.S. Civics** (School of Tomorrow - Accelerated Christian Education, Inc.)

### **Economics - 1 credit**

In this course, students will be introduced to fundamental micro- and macroeconomic concepts, including supply and demand, the role of money, economic systems, globalism and personal finance.

Text: **Economics in Christian Perspective** (A Beka Book, 2nd Edition)

## **GENERAL COURSES**

### **Art - 1 credit**

In this course the student will be taught different techniques of drawing and the use of a variety of mediums. The student will also study famous artists and art forms. This course will encourage the student's artistic confidence and enhance their creativity.

Text: **Drawing on the Right Side of the Brain** (Tarcher/Perigee)

### **Choir - ½ to 1 credit**

In this course, the student will learn the basic techniques of choral singing including following two, three, and four count beat patterns and understanding the different dynamic symbols such as piano, forte, crescendo and decrescendo. The student will also learn to follow the dynamic instructions of the director, reading the basic pattern of different melody lines and singing in harmony. A final performance during the school's annual Christmas Candlelight service and Easter Service will be highlights of the class.

### **Dominican Studies - 1 credit**

In this course, the student will study about the land, history, government, religion, economy and people of the Dominican Republic. The student will also receive first hand experience of the culture by taking several day trips.

Text: **Dominican Republic, Enchantment of the World** (Children's Press)

## **Interpersonal Relationships - 1-2 credits**

In this course students will study topics in interpersonal skills, how to react to different emotional circumstances, and group and individual problem solving. Students will also study various issues relating to relationships, sexuality, self-image, drugs, abuse, divorce, substance abuse, listening skills and other related topics that the counselors deem important to discuss with the students. The counseling department leads this course, and students may earn up to two credits.

## **Health - 1 credit**

In this course, the student will develop skills and habits that can be used in supporting a healthy and productive life. They will study different aspects of health including physical fitness, nutrition, mental health, relationships, body systems, the effects of legal and illegal drugs, and sexually transmitted diseases.

Text: **A Guide to Wellness** (Glencoe/McGraw Hill)

## **Independent Living Skills - 1 credit**

It is the purpose of the Student Independent Living (SIL) course to teach students, who will soon be on their own, to live effectively, be productive adults, and be equipped to make wise and intelligent choices. Students will be given tools to assist them as they choose a job or career, apply for a job, and communicate effectively with others at work. The course will review the uses of a calculator and the importance of computer literacy. Also included will be a basic understanding of the economics of business, buying wisely, managing a budget, and meeting responsibilities concerning taxes, insurance, credit and social security.

Text: **World of Work** (Glencoe Macmillan/McGraw-Hill)

## **Biblical Literature, New Testament - ½ credit**

In this course, students will be exposed to God's redemptive plan expressed in the New Testament. The focus will be on the key people of the New Testament and the many truths it imbues. Selected passages of Scripture are used to increase the student's awareness of the New Testament and its relevancy to their lives.

Text: **Serendipity Bible** for Groups, 4th edition

## **Biblical Literature, Old Testament - ½ credit**

In this course students will be exposed to God's redemptive plan expressed in the Old Testament. The importance of key people in the history of the nation of Israel will be discussed. Various verses will be assigned for the student to apply and to memorize. Selected passages of Scripture are used to increase the student's awareness of Old Testament history and its relevancy to their lives.

Text: **Serendipity Bible** for Groups, 4th edition

## **Biblical Literature, Themes – ½ credit**

In this course students will be exposed to God's redemptive plan for their lives shown throughout the Bible. They will see how God interacts in all aspects of their lives. They will be shown who Christ is and what part he plays in all parts of the Bible. They will be assigned specific verses to aid in revealing God's truth in their lives.

Text: **Serendipity Bible** for Groups, 4th edition

## **Physical Education – 1-2 credits**

In this course the student will be presented with a variety of skills and lessons teaching the proper methods and techniques required for promoting physical health and total well being. This is presented through fitness training, including muscular strength and endurance, skills training of various sports and training to prepare the student for the summer climb to the peak of Duarte.

## **Introduction to Christian Apologetics - 1 credit**

In this course the student will explore the sources of doubt, compare competing worldviews, and investigate various approaches to apologetics, especially classical (logic), evidential (facts), presuppositional (scripture), and fideist (faith & experience).
